# **AGENT BLUE Super Concentrate**

## **TECHNICAL DATA**

---

### **1.0 DESCRIPTION**

This product is a concentrated water-based formula for widespread and long-term control of moss and mould and associated areas. When mixed at a ratio of 1 to 59 with water, it gives a proven solution for the treatment of tile roofs (concrete and decramastic), concrete and masonry surfaces. For severe infestations mix at a ratio of 1 to 34 with water.

The aqueous solution is highly surface active and will rapidly wet surfaces thus giving rapid penetration of the active material. It is also suitable for the meat, food and dairy industry as an effective cleaner and sanitizing agent. It has strong residual properties therefore inhibiting any regrowth over varying time spans, depending on conditions.

### **2.0 OUTSTANDING FEATURES**

- Safety and ease of application
- Freedom from strong or unpleasant odors
- Lasting effect on the surface treated

- Can be used at recommended concentration without the need for a water wash down

### **3.0 APPLICATION**

- 1.0 Mix concentrate at a ratio of 1 to 59 with water and apply liberally to the surface being treated. In cases of severe infestation mix at a ratio of 1 to 34 with water.
- 2.0 Allow AGENT BLUE Super Concentrate to saturate the surface. Most effective control is gained when the surface is dry.
- 3.0 Apply with a rose head type wand or similar low pressure system at the rate of approx. 1 litre to the sq metre or until the surface is saturated.
- 4.0 Remove dead moss and grime after application or leave to the natural washing action of the weather for 24 to 36 months.
- 5.0 A repeat application once surface is clean will inhibit regrowth for an extended period of time. (Approx. 3-5 years depending on local conditions and specific areas).

## 5.0 HEALTH EFFECTS

Swallowed: Moderately toxic by ingestion. If swallowed do NOT induce vomiting. Rinse mouth with water. Give water or milk then raw egg. Contact a doctor.
